Limited funds are available for the Event and Support Services Grant

Application window closing on July 9

The Event and Support Services Grant (ESSG) is designed to assist event centers and supporting businesses that continue to experience negative impacts from the COVID-19 pandemic. Funds from the grant are to be used to reimburse eligible entities for lost revenue.

Eligible applicants may be awarded up to \$100,000 per qualifying location. Businesses must prove a 50% revenue loss from 2019-2020. Award amounts will be based on a 25% loss of revenue.

Eligible entities include:

- Event venues & festivals (indoor and outdoor)
- Florists
- Caterers
- Photographers
- Production companies including DJ's, live performers who are hired for private events
- Promoters
- Decorators

North Dakota Development Fund approves \$847,000 for Q2 2021

Commerce announced that two companies were approved a total of \$847,000 in loan and venture funds through the North Dakota

Development Fund (NDDF) during the second quarter of 2021.

“We continue to see amazing opportunities for economic development across the state. The technology industries, especially agriculture technology, are making a significant impact on our state’s position of being a leader in innovative solutions.”– Commerce Director of Economic Development and Finance Josh Teigen.

Second quarter of 2021 recipients:

- **Kiddie Klubhouse**, a childcare provider in Park River, received a \$97,000 loan to purchase a location for a childcare center to allow the provider to accommodate more children.
- **FarmQA Inc.** in Fargo was approved \$750,000 in venture debt for working capital to help the company scale operations and continue product development.

**Main Street Initiative Artists on Main Street
letter of intent due this Friday**

Artists on Main Street is being offered to North Dakota communities through Commerce to develop an example for rural community development as it relates to arts and culture, downtown revitalization, and historic preservation.

“This is a unique opportunity that offers technical assistance and funding to develop and install art to one of our Main Street communities. Selected communities will receive creative community development training, and one-on-one technical assistance for artists and community leaders from placemaking experts.” –Commerce Economic and Community Development Lead Maria Effertz Hanson

Applicants for the program must:

- Be an existing MSI designated community with a population of 10,000 or less.
- Identify one organizational partner who will help carry out the project.
- Have identified the increase or development of art and/or vibrancy within their action plan or strategic plan.
- Be willing and able to assist in the organization of a community panel to review and select artist project proposals and coordinate artist submissions, presentations, and selection.
- Be able and willing to host one to two creative placemaking workshops for artists from your area.

- Participate in the Main Street ND Summit on Oct. 12, 2021 in West Fargo, North Dakota to showcase the project and learned activities.

Workforce

Applications now being accepted for the Technical Skills Training Grant

The Technical Skills Training grant is designed to support eligible training providers in their efforts to design rapid, non-degree re-skilling programs, expand capacity in existing programs, and/or move training to virtual platforms in order to train displaced workers who will be re-entering the job market and those wishing to make a career change.

New and existing programs that are underway and began after March 1, 2020, may qualify for this grant in order to increase capacity and offset operation and participation expenses. The CRF requires that payments be used only to cover costs that were not accounted for in the budget most recently approved as of March 27, 2020.

Eligible applicants include North Dakota colleges and universities (for non-degree programs), business, non-profit organizations, and/or trades organizations/associations in North Dakota. Internal training programs for incumbent workers are not eligible for this grant

Community Services

Cooling assistance available for low-income North Dakotans with medical needs

In the wake of recent record-setting high temperatures in the state, the North Dakota Department of Human Services announced it is operating a cooling assistance program through September 2021 for qualifying lower-income households.

Cooling assistance aid is focused on adults age 60 and older and other individuals with qualifying medical conditions that put their health more at-risk from extreme heat. To participate, individuals must also qualify financially for the Low-Income Home Energy Assistance Program (LIHEAP), which serves households with incomes up to 60 percent of the

state median income. A household of two can earn up to \$41,118 a year and qualify for LIHEAP.

Operated in partnership with Commerce Community Services and local Community Action Programs (CAP), the cooling assistance program can help eligible households purchase and install a window air conditioning unit, repair an air conditioning unit, or purchase oscillating or window fans.
